



## **KWANTLEN POLYTECHNIC UNIVERSITY – 2024 Upcycled Design Competition INSTAGRAM VOTE GIVEAWAY**

### **Official Contest Rules and Regulations**

Participation in the **2024 Upcycled Design Competition – INSTAGRAM VOTE GIVEAWAY** (the “Contest”) constitutes the entrant’s full and unconditional agreement with and acceptance of these Official Contest Rules and Regulations (“Official Rules”) and all decisions of Kwantlen Polytechnic University (“KPU”) and its agents, which are final on all matters relating to the Contest. This promotion is in no way sponsored, endorsed or administered by, or associated with Instagram. Any questions, comments or complaints regarding the Contest must be directed to KPU and not to Instagram.

#### **1. ELIGIBILITY**

Entrant must be a BC Resident. Open to the public and KPU students aged 16 or older. Faculty and staff at KPU are not eligible. All provincial, municipal and federal laws and regulations apply. The entrant must have or create an Instagram account. The Wilson School of Design will email the Selected Entrants (defined below) a Prize Release form will be sent to each Selected Entrant to be completed and returned to Wilson School of Design.

#### **2. HOW TO ENTER**

Internet access is required to enter the Contest. Participants must also have an Instagram account in order to participate. A free Instagram account can be created by visiting <http://instagram.com> and following the appropriate link to download the free Instagram smart phone application to your mobile device, or visit your mobile device’s application store from your mobile device. In addition to compliance with these Official Rules, Instagram’s terms of use <https://help.instagram.com/581066165581870> apply to all entrants and Entries. Odds of winning depend on the number of valid eligible Entries received during the Contest Period. No purchase is necessary in connection with the Contest. Use and downloading of any third-party applications such as Instagram onto your device is done at your own risk and is subject to the Release (s.7) provided herein below.

To enter the Contest, entrants must:

1. Follow @wilsondesignkpu and @oursocialfabric on Instagram page;
2. Like the entry post; and
3. Visit <https://www.kpu.ca/upcycled> to fill out the entry form with their name, email address, and Instagram handle and vote for their favorite entry by 11:59pm Pacific Standard Time (PST) on April 28, 2023 to receive one (1) contest entry (an “Entry”).

Each entrant can receive a maximum total of one (1) Entry for this Contest. One (1) entrant will be selected through a random number generator that correlates with the total number of votes received (the “Selected Entrant”). The Selected Entrant will be contacted through email as provided through the entry form. The Selected Entrant must prove their identity and proof of registration with a photo of their identification (driver’s license).

Your Entry must not defame or invade the rights of any person, living or deceased or otherwise infringe upon any third party personal or proprietary rights, including any trademark or copyrights. By entering the Contest, you are representing and warranting to KPU that your Entry does not defame or invade the rights of any person, living or deceased or otherwise infringe upon any third party personal or proprietary rights, including any trademark or copyrights.

#### **3. DEADLINES**

The Contest begins at 9:00am PST on April 22, 2024 when the <https://www.instagram.com/wilsondesignkpu/> account uploads the **2024 Upcycled Design Competition – INSTAGRAM VOTE** DETAILS and ends at 11:59pm PST on April 26, 2024 (the “Contest Period”).

#### **4. PRIZING**

There is one (1) prize to be awarded in connection with the Contest. Subject to and in accordance with the Prize Claim Conditions outlined below, the Selected Entrant will be awarded one (1) prize as follows:

- PRIZE DETAILS - i.e. \$100 CAD Our Social Fabric gift card (the “Prize”) Total approximate value: \$100 CAD
- No cash substitutions. Prizes must be accepted as awarded.



## **5. PRIZE CLAIM CONDITIONS**

Wilson School of Design will announce the one (1) Selected Entrant who will be randomly selected from all eligible Entries online at 9:00am PST on May 1, 2024. The Selected Entrant will be notified by email that will include a Prize Release form they will need to complete and return. The Selected Entrant must prove their identity and proof of registration with a photo of their identification (driver's license). The Selected Entrant will have until 9:00am PST on May 8, 2024 to claim the Prize.

The Selected Entrant can claim their prize in person during Wilson School of Design business hours or request that mail delivery be arranged. If it's not claimed within 10 business days, we'll redraw and contact the new winner. We'll keep redrawing until a winner claims the prize/s. In the event of a dispute as to the identity of the person who submitted the Entry to the person claiming the Prize, the authorized account holder of the Instagram account associated with the Selected Entrant's submission will be deemed to be the Selected Entrant in question, unless otherwise determined by KPU.

In either case of claiming the Prize in-person or by mail, the Selected Entrant is required to complete and provide to KPU the Prize Release form no later than 9:00am PST on May 13, 2024 to Wilson School of Design [design@kpu.ca](mailto:design@kpu.ca) releasing KPU, related sponsors, advertising and promotional agencies, participating retailers, and all of their respective directors, officers, owners, partners, shareholders, employees, agents, representatives, successors and assigns including Instagram from any liability in connection with the Contest or the use or misuse or possession of the Prize. Before being declared a "Winner", the Selected Entrant must also first correctly answer without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question posted on the form.

KPU and its authorized agents will collect, use and disclose the personal information you provide when you enter the Contest for the purposes of administering the Contest and Prize fulfillment. Such personal information is collected under the authority of and will be protected, used and disclosed in compliance with British Columbia's Freedom of Information and Protection of Privacy Act.

By entering the Contest and accepting a Prize pursuant to the Prize Claim Conditions above, the Winners authorize KPU and its advertising and promotional agencies and their respective employees or other representatives, to broadcast, publish and otherwise use the Winners' name, photograph, image, statements regarding the Contest and/or the Prizes, and voice for publicity purposes relating to the Contest, without any form of remuneration, approval or further notice.

## **7. RELEASE**

By entering this Contest, you agree to indemnify, release and hold harmless, KPU, and its respective employees, agents and Instagram from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of your breach of the Official Rules, the use of your Entry in the manner set forth in these Official Rules, use of the Prizes or otherwise resulting from your participating in the Contest.

KPU reserves the right, in its sole discretion, to cancel or modify the Contest if fraud, technical failures, or anyone's actions destroys the integrity of the Contest, or if factors beyond KPU's control make it impossible for KPU to administer this Contest as planned. Entrants who have not complied with these Official Rules are subject to disqualification. The Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise, except at KPU's sole discretion. KPU reserves the right to substitute an alternate prize of equivalent or greater value if a Prize cannot be awarded as described.
