3. Business Arising:

4. Reports:

a. Chair's Report:

• Allyson will be following up on the request to amend the Faculty of Arts Double Minor. Hopeful update for next meeting.

b. Dean's Report:

- This past week we had a tour at the Sustainable Agriculture Garden City lands for the Federal Minister of Agriculture and his entourage this seemed to go well, but is always hard to tell. The department did a spectacular job hosting this tour. Thank you especially to Rebecca Harbut and Mike Bomford for preparing the majority of the speeches for this.
- Bringing acknowledgement again to our volume of events. Thank you to everyone involved in these specific people will most likely be missed from these thanks.
- This past Saturday we had the eclipse party at KPU Richmond. Thank you to Laura Flynn for
 playing a major leadership role in putting that together. Great turnout especially for a
 Saturday morning event! Lots of future potential KPU students
- The same afternoon we had the KPU open house in Surrey. Lots of future students connected with advisors at this event so another great event.
- Special thanks to those of you who attended both. You show how valuable the culture of service to our Faculty is. We see you and appreciate you.
- We want to make sure people feel valued when going to these events. One of the ways we
 can do that is by seeing outcomes from them, please do not hesitate to reach out for the
 Dean's office for support in this. We can provide support, and other resources, even swag.
- Thank you to everyone for the shift to cross-departmental advertising at events. This helps support our outreach that KPU is a place you can come to do a lot of different types of science.
- A big part of this is creating ways to encourage future enrollment. This is important not just for filling courses, but allows our programs to be sustainable. This also represents us achieving our academic mission.
- Jeff will be appearing with our HOPS department at the BC Beer events upcoming.
- Not an announcement, but tentative investigation for Faculty of the whole to be held on May 3rd next year instead of the end of August.
 - This could be a good opportunity to restructure the way we do this meeting. Not only do we have to move it due to space issues at the end of August, but this could allow us to move any bylaw changes through Senate before the end of the year, and to better capture the community as a whole (e.g. NR1s, and those who have end of summer vacations)
- Faculty name change has been approved in-principle by the President. Dean is working on the timeline to have all the pieces put in place to actually make this change. This is currently looking like it would come into effect for Fall 2025. Dean is working on investigating the



capacity to alter our external identity in advance in sort of a phased approach, but no word on that yet. Will update when he knows more.

c. Senate Reports:

- Revisions to the Diploma in Computer Aided Design and Drafting were approved.
- The revisions to our Faculty's Bylaws, that were voted on at our August Faculty of the Whole
 meeting, were approved by Senate. Instead of the Dean being a non-voting chair of the
 committee, the new wording states that a chair and vice-chair will be elected from the voting
 members of the committee and they will retain their voting privilege. There were also some
 changes to the wording regarding the workflow for new and revised course outlines.
- AVP Academic, Dr David Burns, gave several updates including an update on the plans for a Faculty of Graduate Studies. This will involve: The Provost's office working on, and seeking consultation on, a proposal for the new Faculty of Graduate Studies; a new policy on graduate studies; and revisions to existing policies to accommodate graduate studies. KPU's first master's program in Operations, Supply Chain, and Logistics Management will also be proposed. Only Masters programs would fall under the purview of the new Faculty (i.e. not post-bacs or graduate certificates). It will be proposed that a Faculty Council be created with reps from the Faculties that are most likely to offer masters degree in future. Since the creation of the new Faculty will require changes to many existing policies, those changes be brought forward as a single omnibus package.

Senate Standing Committee on Program Review (SSCPR):

The Physics for Modern Technology Quality Assurance Plan was approved by the committee.

Senate Standing Committee on University Budget (SSCUB):

 Notice was given that there will be an election for a new committee chair at the next meeting. The President has been chairing the committee since earlier this year, which is not ideal, since the committee and Senate advise the President on the budget.

Senate Standing Committee on Academic Planning and Priorities (SSCAPP):

- Policies for Graduate Studies are being developed, so watch for announcements on these.
- Academic schedules for the next 3 years were approved; note that registrar's office is reserving 3 days to calculate grades, because so many faculty members are filing grades late.
 - People filing grades late are making us lose instructional days, so be sure your grades are filed on time!

Senate Standing Committee on Curriculum (SSCC):

- Met on October 11th
- Acknowledging that Allyson has been elected to be a member on SWIC committee
- Recognition of Prior learning for completion of Trades and Technology programs.
 If you do trades training you can now get Undergraduate credit. This is a great way for those who complete things like Arborist Technician and Landscape Horticulture



programs will get credit they can use towards an Undergraduate degree. Good news for all trades at KPU, but especially relevant for our School of Horticulture

Senate Standing Committee on Research (SSCR):

- o Dr. Burns gave a talk on the proposed standing committee on Graduate studies
- Research committee has previously hosted talks from people on their research at KPU. This has been decided to be taken away from the Senate committee and hosted directly by ORS (Office of Research Services) instead.

• Senate Standing Committee on Teaching and Learning (SSCTL):

- Met on September 28th
- o Dr. Burns gave a talk on the proposed standing committee on Graduate studies
- Update regarding the Pathways Working group: they are currently drafting a procedure for which courses should be in the pathway list to address the high DFW rate.
- We also had a discussion on how faculty may be using AI in their courses, exclusive from Academic Integrity, more just how people may be using it.

Senate Standing Committee on Policy (SSCP):

• We don't have anyone on this committee so cannot provide an update.

• Curriculum Committee:

- Richard Popoff from Chemistry stepped forward to be the chair and was unanimously voted in, and Michael Whitmore from CADD stepped forward to be the vice-chair and was unanimously voted in.
