SUMMARY OF PROGRAM STENGTHS, CHALLENGES AND OPPORTUNITIES FOR IMPROVEMENT

STRENGTHS

The Program Review Self-Study Report and External Review Report both clearly show that the Bachelor of Journalism and Minor in Journalism programs at KPU have several key strengths.

Ministry surveys indicate 90% of KPU Journalism graduates were "satisfied" or "very satisfied" with the education they received.

Surveys of both current students and alumni suggest broad satisfaction with KPU's Journalism program. Some comments from those surveys include:

"I think this program has fantastic instructors. There are also lots of cool journalism courses to take. Overall I feel very well-rounded in journalism from the classes I've taken so far."

"The teachers have real world practical experience and are extremely knowledgeable and helpful. They are easily the highlight of the program."

"Instructors and department staff were very helpful in making sure they were easily accessible for help when it came to course material or even career directions."

"Very communicative, experienced and supportive instructors, a good variety of relevant topics and skills taught, flexible smaller classes, courses change a lot and evolve over time to fit ongoing issues and needs in the profession."

The department has also shown a commitment to ongoing improvement outside of the formal Program Review process. Since the last Program Review, several key initiatives have been undertaken, including:



- Simplifying prerequisites to make it easier for non-journalism students to take upper-level courses as electives and for Bachelor of Journalism students to take the courses they need when they are available.
- Joining KPU's ARTS 4800 Practicum course to give journalism students real-world experience in newsrooms across the region.
- Developing a new course, JRNL 3175 News Reporting, as a direct response to advice from the Program Advisory Committee.
- Offering an upper-level JRNL course in Summer for the first time in Summer 2022 and again in Summer 2023 and Summer 2024, satisfying a common request from students.
- Adopting a statement on Equity, Diversity, Inclusion and Decolonization and developing an action plan to help reach that statement's goals.

CHALLENGES AND OPPORTUNITIES

The most consistent criticism of the program, which several students mentioned in the surveys, is the range and availability of upper-level JRNL courses. As a small program, many upper-level JRNL courses are only offered every other year, which can make it difficult for students to meet degree requirements or to take a course they are particularly interested in. The program has taken some steps to address this, including offering upper-level JRNL courses in the Summer and adding some upper-level JRNL courses with wider appeal among non-journalism students (such as JRNL 3260 Future of News). The Program Review Self-Study Report made several recommendations that could further boost upper-level enrolment, such as setting up an articulation agreement with BCIT and developing another upper-level JRNL course with wide appeal.
