Membership Categories

Eligibility for Full Membership (bylaws 2.3 & 2.4)

A Person is eligible to be accepted as a Full Member if he or she:

- (a) is a KPU Retiree; and
- (b) is interested in advancing the purposes and supporting the activities of the Society.

Eligibility for Associate Membership

A Person is eligible to be accepted as an Associate Member if he or she:

- (a) is fifty-five (55) years of age or older;
- (b) is one or more of the following:
 - (i) a spouse or partner of:
 - a. a Full member; or
 - b. a deceased Person who was a full Member; or
 - c. of a deceased Person who would have been eligible for full membership;
 or
 - (ii) a retiree of another post-secondary institution who lives in the Greater Vancouver Regional District; or
- (iii) an employee of KPU who will become a KPU Retiree in the next 12 months; and (c) is interested in advancing the purposes and supporting the activities of the Society.
