## I. Minutes of 21 October 1983

One alteration: OLI, New Upper Level European course should read:

New Upper Level Canadian course. Minutes approved.

### II. College Reports

- Overall concern over the loss of history positions at community colleges, and continued enrolment increases despite Budget cutbacks. The replacement of full-time instructors by part-time is a major problem area.
- A number of colleges still suffer from inadequate library funding for their history programs.
- The general feeling among college instructors is that these conditions are jeopardizing the quality of history programs and therefore require close attention.

## Selkirk

The closure of David Thompson has resulted in the reduction of history offerings from 6 sections to 3. Bill Sloan's position has been reduced to one-half time.

## Malaspina

Clarence Karr on sabbatical leave 1984-85. The temporary replacement will not cover all courses taught and therefore expect to lose one history section.

#### Kwantlen

History offerings reduced by 4 sections and American course no longer in existance. The previous 11 courses have been reduced to 7.

### F.V.C.

Status quo in history offerings. Concern expressed over inadequate library funding, reduction in articulation money and increased enrolments. Report on New Caledonia history offerings presented. See further discussion: III,C.

### North Island College

Budget cutbacks affecting capabilities. Expect to lose only full-time history position.

#### Camosun

Status quo in history instructors, increased productivity. New course added: B.C. Development.

#### Langara

Status quo - staff and courses.

#### Douglas College

Status quo. Funding for American course required in order to expand offerings.

### Okanagan College

Expect increase in productivity, concern over low library budget. Staff reduction by one-half position.

### N.W.C.C.

Diversified teaching load continues. Staff reduction of one-half position.

#### Cariboo College

Status quo. Impact of increased productivity remains the major concern,

#### S.F.U.

History staff reduction by retirement:  $l_2^1$  positions. Status quo in offerings.

#### IL.B.C.

History staff reduction by retirement - one position. Status quo.

#### U. Vic.

Status quo.

#### OLI

Status quo.

- A. OLI Business arising from 21 October 1983 meeting:
  - Response to Dr. Mugridge's reference as to "face-to-face instruction." See attached memorandum from Jocelyn Calvert, University Programme Coordinator.

  - Discussion: the role of the articulation committee and universities in preserving the integrity of history offerings resulted in the following motion which was voted on and approved:

"That the university representatives to the History Articulation committee take appropriate action to express concern over the integrity and transferability of college history programs and the qualifications of instructors."

- The historians present at the meeting exchanged their course outlines in order to bring each other up to date on current course offerings. This was a useful articulation and professional development exercise.

- B. Discussion with regard to insufficient funding for instructors to attend two meetings led to the following motion which was voted on and rejected.

"Moved that there be only one meeting a year."
Discussion continued on the importance of October business meeting, and Spring business and professional development meeting.
